ENTRY FEES & MEMBERSHIP

There is **no entry fee for current GNAL members.**

Artists who are not currently members may purchase a GNAL membership at artwork drop-off.

All memberships are valid from **September 1, 2026 through August 31, 2027.**

Membership Rates:

Individual — \$50

Senior — \$40

Student — \$15

ARTWORK REQUIREMENTS

- Artists may submit up to **two (2) original works of art.**
- Any artwork measuring **more than 48 inches on any side must receive prior approval from GNAL.**
- **Three-dimensional (3D) artwork must be pre-approved by GNAL** prior to submission, as the exhibition space has limited accommodations for 3D works.

To help expedite artwork drop-off and streamline the check-in process, artists are strongly encouraged to complete the online artwork label and waiver form in advance.

Membership fees may also be paid online ahead of time or in person at drop-off.

PLEASE READ CAREFULLY AND FOLLOW ALL REQUIREMENTS

Failure to comply with the requirements outlined in this prospectus may result in artwork being ineligible for exhibition or removed from display.

EXHIBITION AWARDS

Awards will be presented in accordance with GNAL policy and are dependent upon the minimum number of eligible entries received in each category.

SUBMISSION RULES & ELIGIBILITY

- The exhibition is **open to current GNAL members**, including both Emerging and Established artists. The 2026–2027 membership year runs from **September 1, 2026 through August 31, 2027**. Artists who are not current members may purchase a membership prior to or at artwork drop-off.
- Students 18 years of age and younger who have taken a GNAL class within the past year are also eligible to participate. All youth submissions will be entered in the Under 18 category. Submitted artwork does not need to have been created during a GNAL class. A parent or legal guardian must sign the Release and Waiver for all artists under 18.
- Artwork previously exhibited in a GNAL juried art show is not eligible for submission.
- Each artist may submit up to two (2) original works of art.
- Any artwork measuring more than 48 inches on any side must receive prior approval from GNAL before submission.
- Three-dimensional (3D) artwork must be pre-approved by GNAL prior to submission due to the exhibition space's limited accommodations for 3D work.
- All artists must submit a completed and signed Release and Waiver, either online in advance or in person at drop-off.
- GNAL reserves the right to reject any artwork based on content, condition, presentation, safety, or failure to meet the requirements of this prospectus.
- Artwork may be listed For Sale (FS) or Not For Sale (NFS). Price on Request (POR) will not be accepted.

FRAMING & DISPLAY REQUIREMENTS

All two-dimensional artwork must be properly framed or otherwise professionally presented and securely wired for hanging.

- Braided picture wire is required.
- Sawtooth hangers, string, temporary fasteners, or other unsuitable hanging methods will not be accepted.
- Frames, supports, and hanging hardware must be secure and appropriate for the size and weight of the artwork.
- GNAL wire kits are available for \$5 and may be purchased at the studio or at artwork drop-off.

Artwork that cannot be safely and securely installed may be refused.

Approved 3D artwork must be self-supporting, stable, properly mounted, and safe to display.

Size and weight must allow the work to be safely moved by one person unless prior arrangements have been approved by GNAL.

Original photographic works are welcome, including both traditional and digital photography, and must meet the same professional presentation and hanging requirements outlined above.

ORIGINALITY & PLAGIARISM

All submitted artwork must be the artist's original work.

Copies or reproductions of published artwork, photographs, clip art, books, videos, or other existing works will not be accepted in GNAL exhibitions or events. This includes images sourced from the internet, including those identified as "royalty-free."

AI art is NOT permitted in any form.

At the discretion of the GNAL Board, any work determined to have been copied from another artist or source may be removed from the exhibition immediately. Any awards associated with the work will be rescinded.

Artists found in violation of this policy may be prohibited from participating in GNAL-sponsored exhibitions and events for one full year.

DROP-OFF & PICK-UP

- All artwork must be delivered to Von C Brewing Company at the designated drop-off date and time and must comply with all requirements stated in this prospectus.
- GNAL and Von C Brewing Company do not insure submitted artwork and assume no responsibility for loss, theft, or damage. Artwork is exhibited at the artist's own risk.
- All accepted artwork must remain on display for the entire duration of the exhibition.
- Artwork may not be removed early without prior authorization from GNAL. Unauthorized early removal may result in forfeiture of any award received and may affect eligibility for future GNAL exhibitions.

SALES

A 30% commission will be retained by GNAL on all artwork sold during the exhibition.

All payments for artwork must be made directly to GNAL. GNAL will manage exhibition sales, including cash and credit card transactions.

GNAL will issue the artist's remaining proceeds **within one (1) business week** of receiving payment for the sold artwork.

LATE PICK-UP & STORAGE FEES

Artists are responsible for picking up their artwork at the designated date and time unless prior arrangements have been made with GNAL.

Artwork not picked up as scheduled will be subject to:

\$20 per day storage fee

+ \$10 transportation fee

Artwork requiring transportation back to GNAL will be handled with reasonable care; however, GNAL assumes no responsibility for loss or damage resulting from transportation or storage.

Unclaimed artwork will be securely stored at GNAL for up to 30 days. It is the artist's responsibility to contact GNAL, arrange a pickup time, and pay all applicable storage and transportation fees.

GNAL will make reasonable attempts to contact the artist. Artwork remaining unclaimed after 30 days will become the property of GNAL, and any associated cash awards or unpaid proceeds may be forfeited.
