**(Artwork as small as 12 x 12 will be accepted on occasion at the discretion of the juror)**

GNAL and the Medical Providers at the Braemer Medical Arts Building at the Jefferson Einstein Montgomery Hospital are pleased to offer an opportunity to showcase GNAL Members with professional works of 2-D art in an ongoing gallery presence in their office. Original artwork only will be displayed, prints of artwork are not admissible (not including photography). This is a chance to present your work in a beautiful location with visibility by visitors, patients, and their families. This exhibit runs for four months and art must be for sale.

If a piece is sold it must be replaced with another piece for the remainder of the exhibit. Previously exhibited work at GNAL is eligible. Artists will be contacted to meet the patron and accept payment for a sale - we encourage you to meet at the Braemer Gallery or GNAL, at which time you are invited to replace the piece with another for the remainder of the show.

All reasonable care will be taken in handling work. GNAL does not insure your work. While the Braemer gallery is in a well-lit, high traffic area, the building is open to the public, so entering the show is at your own risk. You must carry your own insurance - Braemer and GNAL are not responsible for loss or damage to artwork.

As the artwork will be displayed in a public area (in a medical facility) it should reflect suitable subject matter that is pleasant and uplifting to offer healing and joy to patients and visitors. Please stay with the theme provided. The jurors reserve the right to eliminate any artwork for unsuitable subject matter, quality, craftsmanship, and overall professionalism. Artwork should be current and paper, boards, and matting free from yellowing, stains, or wear and tear.

GNAL Show Team & Chairpersons along with our Jefferson Einstein contact act as jurors for the Braemer exhibit. All work must be matted and/or framed, except for wrapped canvases, which must be painted on the outside edges. The work must be 2-dimensional with a properly installed braided wire for hanging.

Artists will be contacted only if the work is NOT accepted into the show.

### **EXHIBITION AWARDS**

- This is a juried, non-awarded exhibition

### **SUBMISSION RULES AND ELIGIBILITY**

- Open to current members only. Membership begins in September 2025 and runs through August 2026. You may opt to become a member at drop-off.
- Any work previously shown is welcomed.
- May exhibit up to 3 pieces.
- All artists must submit a signed Release and Waiver.
- Any work may be rejected for content or presentation if determined to be unsuitable for exhibition.
- Entries must be for sale. NO POR or NFS accepted.
- Work with temporary supports or fasteners will not be accepted. ALL two-dimensional work must be properly framed and wired with braided wire ONLY. String, other types of wire, sawtooth hangers, etc. will not be accepted.
- Original photographic media accepted, traditional and digital. PROPERLY FRAMED AS NOTED ABOVE.

### **PLAGIARISM**

No copies of published art, photos, no clip art, books, videos or artwork will be accepted at any of our shows or events. This includes images from the internet, even those that are “royalty free.” At any time, and at the discretion of the Board, if work is deemed to be copied from another artist’s work or images, it will be removed from display immediately, and any prize awarded will be null and void. The artist will also be banned from any show at or sponsored by GNAL for ONE FULL YEAR.

### **DROP OFF / PICK UP**

- All entries must be delivered following the requirements stated in this prospectus.
- GNAL does not assume responsibility for any work.
- GNAL does not insure your work. ENTER AT YOUR OWN RISK

### **SALES**

- 25% commission will be charged on all work sold during the show.
- Buyer’s check must be made out to the artist. The artist assumes responsibility for payment of proper commission due to GNAL within 10 days of the sale. (GNAL will accept cash or check)

### **FEES FOR LATE PICK UP**

A Storage Fee of \$10 per day *will be* charged for storage of any works not picked up at designated time, unless prior arrangements are made with GNAL.
